Brief summary

In this deliverable, it explained what are the „market of researchers“ and „market of stakeholders“, launched during the 1st meeting of the Living Labs and provide physical evidence of their occurrence.

The Markets‘ concept was envisaged before the current pandemic, under the assumption that it would be implemented during a 1st physical meeting of the WP4 Living Labs. The idea was to recreate the environment of a fair where stakeholders would be, each at their own booth, „selling“ their challenges to researchers and students and presenting their organizations, products, services and/or their research/innovation-related interests.

Given the impossibility of holding this meeting presentially, we had to rethink the whole way of doing the activities planned, which led us to held the markets on wonder.me platform.

Overall, the goals we had set both for the meeting of the Living Labs and for the markets were achieved, but not without losses in the productivity, motivation, and engagement level of the different participants, who would rather meet in person and be working together in the same room than have just another full day/week of online conferences.

1. The Scientific Markets

The online „Market of Stakeholders“ was a short-duration networking session (cc. 50 min) held on the wonder.me platform with the purpose of creating a „friendly“ environment that promotes informal talks of researchers (both the ones already integrated in the networks, as well as the ones in the bank of researchers) with stakeholders. These networking sessions are much more dynamic than the conventional online meetings and allow participants to quickly jump from one conversation with one stakeholder to the next, leaving room for the next researcher – it works like a „scientific speed-dating“ event online.

Likewise, the „Market of Researchers“ is realized in the same format but aims to promote informal talks of researchers from the bank of researchers with the ones who are already integrated in the 3 research networks.

During the 1st meeting of the WP4 Living Labs, one Market of Stakeholders and one Market of Researchers were held during the open session of June 7. Another Market of Researchers was held on June 9 (see section 2).

Preparation of the Markets

Together with personalized emails and programmes (a and b, respectively), we prepared guidelines for wonder.me to send to all market participants, in order to make their identification easier to the other participants. The Researchers from the Bank of Researchers were invited to attend the two open sessions of the 1st meeting of the Living Labs, held on June 7 and 9, whereas stakeholders were only invited to the June 7th. Nonetheless, most of them were present in the working sessions of the networks that were ongoing from June 7-15, and participated in different types of activities (e.g. workshops to discuss challenges and sessions focused on setting up a proposal plan for our internal call – see D4.7).

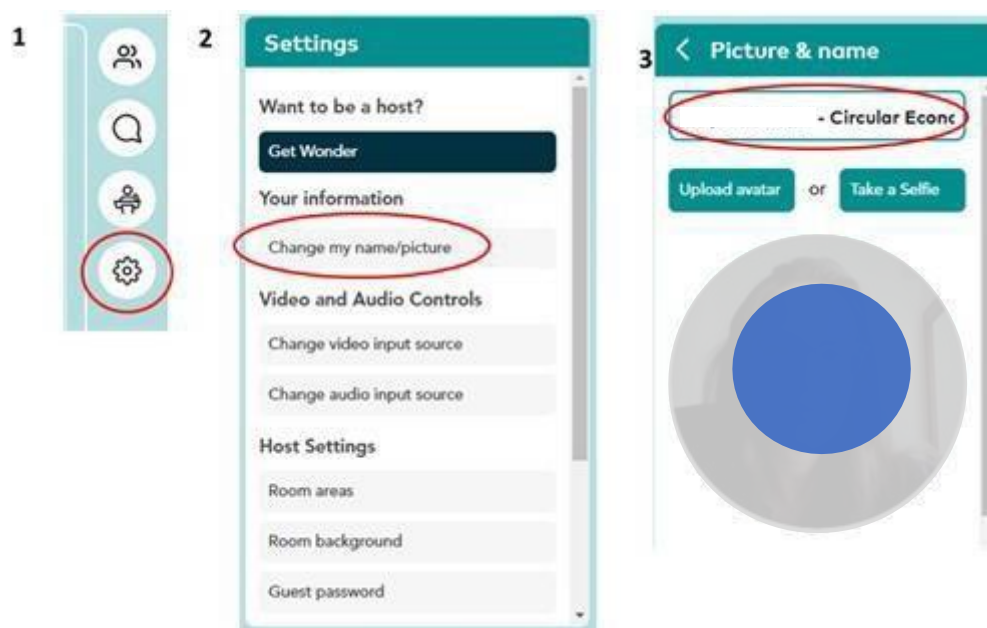
