

# Terms & Conditions for the video competition “EU matters”

## 1. Eligibility to participate

All individuals are eligible to participate.

By participating, the persons involved agree to the terms and conditions of this competition and the relevant details. The University of applied Sciences St Pölten reserves the right to check compliance with the conditions of participation, in particular the eligibility to participate (as well as the personal details and any exclusion from the prize draw).

## 2. Participation procedure

The participant produces a short video (approx. 00:30 to a maximum of 02:30 minutes) with his/her contribution. All audiovisual forms (e.g. personal statement, short interview, report, collage, animation, explanatory video, etc.) are permitted.

The participant shares his/her contribution through a file sharing service like for example WeTransfer, enabling the organizers to download the submissions.

The participant sends the link for downloading his/her contribution via the E<sup>3</sup>UDRES<sup>2</sup> website submission form.

The E<sup>3</sup>UDRES<sup>2</sup> office will upload selected videos on the E<sup>3</sup>UDRES<sup>2</sup> European University YouTube channel and distribute selected videos via the E<sup>3</sup>UDRES<sup>2</sup> social media channels.

## 3. Selection process, Prizes and communication about prizes

The award winners are selected by a jury of experts compiled of the leaders of the E<sup>3</sup>UDRES<sup>2</sup> Alliance as well as external experts and students.

The decision is based on creativity of the EU message, uniqueness of the idea and strong commitment to EU values.

We award at least three prizes donated by private individuals:

- 1<sup>st</sup> prize: 750 Euros
- 2<sup>nd</sup> prize: 500 Euros
- 3<sup>rd</sup> prize: 250 Euro

The prizes for this competition will be distributed to the winners by a private individual. The organizer holds no responsibility for the distribution process beyond facilitating communication between the winners and the private individual. Winners are solely responsible for providing accurate and up-to-date contact information for prize delivery. The organizer will not be liable for any delays, damages, or discrepancies related to the distribution of prizes by the private donor. By participating in the competition, entrants agree to release the organizer from any and all liability associated with the distribution of prizes.

Videos featuring defamatory, violent, racist, sexist, homophobic, or pornographic content, or those that could potentially harm the physical or moral well-being of individuals, will be promptly disqualified from consideration.

#### **4. IPR**

All rights are reserved to the producer. The producer is responsible for ensuring that he/she is the owner of all necessary rights and indemnifies and holds the organizer harmless.

The Producer grants the St Pölten University of Applied Sciences and the partner universities of E<sup>3</sup>UDRES<sup>2</sup> a temporally and geographically unlimited license to use the work for all exploitation rights in accordance with the Austrian Copyright Act.

## 6. Data Protection
